## DEPOT REGULATIONS FOR QUICK HGV CLEARING

- Check clearing and traffic situation before driving to the depot
- Comply with the operational traffic control
- Check order details and documents prior to departure and hold in complete readiness upon arrival at the depot
- Follow the safety regulations and instructions of the depot personnel
- Undo latches in the waiting lane
- Open the container doors for inspection and accompany the depot inspectors
- Check the containers straight after acceptance and if necessary only reject them for a justifiable reason.
- Leave the depot quickly after clearing



# REQUIREMENTS FOR DRIVING TO THE HAMBURG DEPOT

Good preparation and compliance with the rules compiled in this brochure are requirements for quick clearing of the HGV in the empty container depot. Each depot in the port of Hamburg offers drivers and dispatchers multiple possibilities to provide a clearly co-ordinated data situation before driving to the gate.

#### Use our

- Public gate cameras
- Webpages for reference checking
- Hotlines in the interchange
- Late opening hours
- Offers for special agreements
- Possibilities for advance notification

The approval of larger slots should always be obtained in advance with the depot interchange.





#### Advance notification helps

When delivering and collecting it is very important that all data is complete and correct! For this reason, it would be very helpful if discrepancies are clarified beforehand.



#### Simplification of standards

The use of standardised forms for delivery and collection of containers in all depots facilitates clearing at the gates and forms the basis for further automation.



#### Web solutions
